Under Sections 552.021 and 552.023 of the Texas Government Code, you are also entitled to receive and review the information. ## Information and Instruction Sheet

### General Information

1. All applications must be received or postmarked by **January 31, 2016** to be considered.
2. A **current commercial FINFISH license and plates will be required to complete a buyback transaction**. If you have not purchased a current commercial finfish license but want to be considered for the buyback we will consider your application, but you will be required to purchase the license before the buyback of the license can be completed.
3. Each application for the buyback period will be ranked against all other applications within the same buyback period.
4. Texas Parks and Wildlife maintains the right to accept or deny buyback applications based on funds available and other factors. The Department will establish the maximum amount that will be paid for each individual license. If your bid is greater than this maximum amount, your bid must be rejected during this application period. Please note that you can resubmit buyback applications for future buyback periods. Texas Parks and Wildlife will hold at least one buyback period per license year.
5. The department will attempt to contact each applicant within 21 days of the end of the application period to indicate acceptance or rejection of the bid. If accepted you will have 15 days from the date of the acceptance letter to notify the department that you intend to sign a contract and set up a time to make the license transfer.
6. Department records will be used to verify all information supplied by or pertaining to the applicant's history in the finfish fishery. By submitting this application, you are certifying that you were eligible to purchase the license that you are offering to sell.
7. Your individual bid information on this application will remain confidential.
8. Payment for any prior monies owed the department must be paid in full prior to completing a buyback transaction. Payment for any prior monies or liens owed to the state or the Attorney General's office will be seized in full prior to the applicant receiving any remaining balance.
