## **BAIT DEALER INDIVIDUAL APPLICATION (Type 312)**

A Bait Dealer Individual License is required for a person to catch and sell his/her own catch of minnows, fish or other aquatic products (except shrimp) for bait. To sell bait harvested from the public fresh waters of this state, a Permit to Possess or Sell Nongame Fish Taken from Public Fresh Waters is also required in addition to the Bait Dealer Individual License.

Bait Dealer Individual License Fee: \$38 License expires on August 31.

You may purchase a new license beginning August 15 at any Texas Parks and Wildlife Department law enforcement office (listed on the back) or by mailing this application with required payment to the address at the bottom of this page. Allow three weeks for processing. This license is not effective until September 1.

Nongame Fish Permit Fee: \$60 Permit expires on December 31.

You may apply for a nongame fish permit by submitting form PWD-1027 by mail. Forms can be found at: <http://tpwd.texas.gov/publications/fishboat/forms/>.
