Disqualifying Violations

Disgualifying violations may include (but are not limited to):

The Department MAY REFUSE to issue or renew a party boat operator license if:

- An applicant is liable to the state under Parks and Wildlife Code §12.301; or
- An applicant has a final conviction or has been assessed an administrative penalty for a violation of:
 - o Penal Code, Chapter 49 involving the operation of a motorboat; or
 - o Parks and Wildlife Code, Chapter 31, involving reckless or negligent behavior, or behavior that placed passengers in peril; or
 - o A provision of the Parks and Wildlife Code that is punishable as a Parks and Wildlife Code:
 - Class A or B misdemeanor, state jail felony, or felony;
 - o Water Code, §26.121; or
 - Any federal or state law relating to the sale, distribution, financing, registration, or taxing of a vessel, motorboat, or outboard motor; or
- The department has evidence that the applicant is acting on behalf of or as a surrogate for another person or entity who has a final conviction or has been assessed an administrative penalty for any violation listed above.

Boating Violations

Specific **boating violations** disqualify an applicant from submitting 25 hours of experience operating a party boat, and require qualification based instead on 4 hours of observation and 4 hours of documented operation. These include:
