


<u>Scope</u>: Contractor shall furnish all labor, equipment, tools, materials, transportation, and incidentals necessary to remove the existing asphalt shingle roof on two (2) buildings and install new metal panel roofs. Work shall include demolition, carpentry, painting, and metal panel roofing. Contractor is responsible for verifying all dimensions and existing conditions.

<u>Location</u>: Matagorda Island Wildlife Management Area (WMA), on Matagorda Island, not far from Port O'Connor, TX. Island is not accessible by car or truck. No bridge exists. The marina area on the island is approximately 150'x200', and a 100' long barge has been routinely used for work on the Island. Contractor is responsible for providing their own transport to the Island, for personnel, equipment, and materials.


