General Scope of Work: Construction and demo of cedar picket and cedar rail fencing at the Rim Cabin area and construction of cedar picket fencing and road gate near the Maintenance Complex.

Project Schedule: All work shall be completed within two hundred-seventy (270) calendar days commencing on the date specified in the Notice to Proceed. This performance period includes completing the various aspects required to complete the Work, including submission of all Submittals, mobilization, procurement, installation, testing, inspection, and delivery of documents described in Terms and Conditions.
