PURPOSE OF ADDENDUM: QUESTIONS AND ANSWERS/CLARIFICATIONS

Except as provided herein, all terms and conditions of the document referenced herein, remain unchanged and in full force and effect. The following are specifications to this solicitation. This Addendum may be attached to and form a part of the referenced solicitation document and any resulting awarded contract and may be considered in your response.

1. **Section I, Pg 6 of 42, Parts and Equipment** 6.2.5. Contractor to provide current H125 and C208 pricing catalog detailing MSRP and billing based on MSRP discount percentage offered to TPWD. Bidder must supply hourly labor rate and parts pricing.

Question: Would TPWD consider revising para 6.2.5. to align more closely to industry standards and a cost-plus fee schedule?

Answer: Respondents shall submit flat rate for services and a discount from list price. TPWD will not update pricing to a cost plus fee schedule. Please see updated Exhibit B, Pg 36 of 42, Price Schedule.

2. **Section I, Pg 7 of 42, Warranty/Guarantee. Question** Would TPWD revise the warranty to terms to align with industry standards more closely, whereby the contractor is only responsible for workmanship related warranty items or assisting with warranty claims from the part OEM or Aftermarket provider?

Answer: Section I, Pg 7 of 42, Warranty/Guarantee, is revised as follows:

6.5. Warranty/Guarantee: The workmanship performed on TPWD aircraft is to be warranted against defects in installation and work conducted for a period of one year from date the services is inspected and accepted by the TPWD.

6.5.1. Contractor must guarantee replacement of improperly installed or repaired equipment during the initial Contract period and any exercised renewal options.

6.5.1. Contractor must guarantee expeditious work with manufacturer on warranted

parts and offer replacement services of those parts for the period of the warranty with normal contractor labor rates.

6.5.2. Any replacement parts necessary due to workmanship must be received and installed within two weeks of written notification unless otherwise agreed by both parties prior to the two week end.

6.5.3. If workmanship is at fault, contractor will provide any necessary replacement parts, labor, and associated costs free of any charge, including any shipping costs if necessary to complete the work properly.

6.5.4. Damages: Any damage done to the aircraft by the Contractor will be repaired by Contractor at their cost and TPWD's satisfaction. All repairs must be in accordance with the manufacture guidelines or FAA specifications for repair(s).

3. Question: Would TPWD consider changing these requirements to allow travel and consumable fees to be billed separately based on the job vs. trying to combine them into a labor rate?

Answer: Awarded Contractor may bill travel expenses as a separate line item. Request for reimbursements can not exceed the GSA Travel Reimbursement Rates. <http://www.gsa.gov/perdiem>

4. Question: Would TPWD consider revising parts pricing into a schedule based on cost plus fee associated with parts? **Answer: Please see answer #1**
