Objective: To acquire by conservation easement 5,685 acres or any part or percentage of interest of Storm Ranch, as funding permits.

Accomplishments:

During this reporting and contract period, Hill Country Conservancy and the Storm Family completed acquisition of Phase I of the conservation easement (2,283 acres), and Phase II of the Storm Ranch conservation easement, (1,318 acres). Phase I was acquired in August 2005 for \$3,847,000, of which USFWS contributed \$1,044,550. Phase II was acquired in May 2008 for \$2,354,672, with USFWS contributing 1,766,004.

An Easement Documentation Report was created for each property and signed by the Grantor of the conservation easement and HCC at closing. Annual monitoring reports were completed and filed by Hill Country Conservancy Director of Land Stewardship Frank Davis in each of the 3 years following acquisition of Phase I. No violations were noted during any of those monitoring visits or interviews with the Storm family.

The Storms completed brush management and habitat restoration work in 2007 on two large pastures (the "Pear Tree" and Arrowhead" pastures) totaling approximately 500 acres. A Natural Resources Conservation Service grant to improve water quality in the Edwards Aquifer through Ashe juniper chainsaw removal provided 50% of the funding for that project. In addition, the Storms continued preparations for a prescribed burn with funding assistance from a USFWS Private Stewardship Grant. However, the recent drought and county burn bans have prevented implementation of the burn. There are preliminary plans to perform the burn in late winter or early spring of 2009. Hill Country Conservancy has hosted several volunteer days to assist with these projects, along with on-site special events and tours to increase public awareness of conservation and habitat issues.

Finally, in September 2008, Hill Country Conservancy applied for an additional \$6,000,000 through the USFWS Nontraditional Section 6 Grants Program, for acquisition of a conservation easement on the remaining 2,084 acres of the ranch. The grant proposal included further protection for the endangered Barton Springs Salamander, in addition to creation and enhancement of habitat for two endangered songbirds, the Black-capped Vireo and the Golden-cheeked Warbler.
