
The Solana Ranch Recovery Land Acquisition Project TX E-154-RL-1 is successfully concluded. The Nature Conservancy (TNC) purchased a conservation easement on 256 acres out of the Solana Ranch in Bell County, Texas, from the landowner, Michaux Holdings Ltd., on July 5, 2016. The conservation easement fulfills the project goals by protecting the three springs on the Solana Ranch property which contain known populations of Salado salamanders (*Eurycea chisholmensis*) from development and other threats. TNC will monitor the easement in perpetuity.

As anticipated, the conservation easement was purchased with \$881,250 allocated by U.S. Fish and Wildlife Service (USFWS). That price was less than the fair market value of \$1,500,000 as determined by appraisal. The balance was contributed by the landowner as a bargain sale.

There were no significant deviations in project objectives or approach. A minor deviation was that the conservation easement was originally intended to reference a grazing plan. However, the landowner's grazing plan governed a larger area than the 256 acres placed under conservation easement and some of its provisions were non-applicable to the easement, so the parties mutually agreed to cover grazing and other ranch management activities on the 256 acres within the conservation easement document. The terms of the conservation easement were reviewed and approved by USFWS and Texas Parks and Wildlife Department (TPWD) personnel.

With this easement acquisition, the majority of known populations of the newly listed Salado salamander will be permanently conserved, along with other aquatic fauna associated with the natural springs on the Solana Ranch. TNC appreciates the opportunity to work with USFWS and TPWD and apply Section 6 funds to acquire a significant conservation property which accomplishes multiple objectives.
