Description of Required Documents:

Vessel/Boat Records Maintenance (Form PWD 143M) - is used to renew TX vessel/boat registration; replace a lost or destroyed vessel/boat title, registration decals or Certificate of Number ID Card; obtain additional ID cards; or make changes or corrections to your name, mailing address or vessel/boat description.

Outboard Motor Records Maintenance (Form PWD 144M) - is used to replace a lost or destroyed outboard motor title, or to make changes or corrections to your name, mailing address or outboard motor description.

Description of Required Documents (Continued):

Request to Release a Lien, Add a New Lien, or Correct a Lien (Form PWD 403) - is used to release, add or correct lien information to an existing record.

Renewal Request - includes the following options:

- (1) Renew registration online at www.tpwd.texas.gov/boatrenewal/
- (2) Renew in person at a TPWD or participating County Tax Office with one of the following:
 - Renewal Notice, or
 - Written Request for Renewal. (Handwritten letters should include the TX number and/or hull identification/serial number, the owner's printed name, address (new and old if changing address), and signature), or
 - Letter of Authorization (PWD 581), or
 - For Owner on Record or Spouse * (with the same last name and address – government photo id is required) Printed Name & Signature on Transaction Receipt.
- (3) Renew by mail - submit the fee (check or money order) and one of the following to: TPWD, 4200 Smith School Road, Austin, TX 78744.
 - Renewal Notice, or
 - Written Request for Renewal. (Handwritten letters should include the TX number and/or hull identification/serial number, the owners printed name, address (new and old if changing address), and signature.)

* A spouse renewing registration with an address change must have either the green renewal notice (no signature needed), or a PWD 143M signed by the owner of record, or a signed Letter of Authorization (PWD 581) from the owner of record.

Letter of Authorization (Form PWD 581) - is used to designate another person to submit and pick up associated paperwork when the owner of record or applicant/purchaser can not come in person. **This form is not a power of attorney and does not provide signature authority to the person bringing in the paperwork.** The PWD 581 must be accompanied by completed and signed applications required for the type of transaction being requested. The letter of authorization can be used as the application for registration renewal, decal and ID card replacements, however all other associated requests and applications must be signed by the owner of record.

In lieu of the form PWD 581, a handwritten letter from the owner of record or applicant/purchaser is acceptable. This letter must include a statement authorizing someone other than the owner of record or applicant/purchaser to conduct a specific registration and titling transaction for the owner of record or applicant/purchaser; the name of the person authorized to do business for the owner of record or applicant/purchaser; a description of the vessel and/or outboard motor (make, TX or serial number, and year built); and the signature of the owner of record or applicant/purchaser.

The spouse (with the same last name and address as the owner of record) may request replacement ID cards and decals and sign the PWD 143M without a letter of authorization; government photo id is required. A spouse requesting replacements with an address change must have either a PWD 143M signed by the owner of record, or a signed Letter of Authorization (PWD 581) from the owner of record.

Power of Attorney (Form PWD 1055)- is a legal document used to designate a representative (individual or company) to conduct business (sign) on behalf of another. Signatures must be notarized.

Description of Required Documents (Continued):

Written Notification - If you want to change the address of a TPWD vessel/boat and/or outboard motor record that is in your name, you may update the address online at no cost at www.tpwd.texas.gov/boatrenewal, use form(s) PWD 143M and/or PWD 144M OR write a letter including your boat and/or motor TX Number(s) and/or serial number(s), current mailing address, new mailing address, and signature. Mail the letter to Texas Parks & Wildlife Department, 4200 Smith School Road, Austin, Texas, 78744.

Affidavit of Fact (Form PWD 314) is used to provide explanations of specific situations.

All affidavits must include: (1) the date of the statement, (2) the description of the vessel and/or outboard motor (make, TX or serial number, and year built), (3) details explaining your situation, (4) required signature.

The specific situations below require the following information:

***Owner/Lien Holder/Description Corrections** - When the boat/outboard motor record contains an error on the owner/lien holder name, or description, an affidavit from the titled owner or lien holder must be submitted specifying what information needs to be corrected and why.

***Legal Name Changes** - (Marriage, Divorce, or other court ordered Name Change) require Legal Document(s).

Documentation Supporting Error - documentation provided by the customer or processor which clearly shows the error in coordination with office research of past transactions (electronic scanned images) which show the error. Processor Error transactions require a photocopy of the documentation on file with TPWD highlighting the error, or the processor's signed statement confirming the error (by review of documents on file with TPWD), or the processor's signed statement providing acceptable reason (when the correction is not due to TPWD error).

Texas Vessel Title - Certificate of Title is a negotiable document for a vessel which shows description, name and address of owner and (if any liens) lien holder information.

Texas Outboard Motor Title - Certificate of Title is a negotiable document for an outboard motor which shows description, name and address of owner and (if any liens) lien holder information.

Statement That Title is Lost/Destroyed/Not Yet Fulfilled (Printed) - You are required to surrender the existing Certificate of Title unless it is lost, destroyed, or has not yet been printed. If the title is lost, destroyed, or has not yet been printed the owner/lien holder/TPWD processor must indicate so by selecting the applicable box on the form PWD 143M/144M or form PWD 403.

Registration Decals - You are required to surrender the existing registration decal unless it has been lost, destroyed, or has not yet been issued.

Statement That Decals are Lost/Destroyed/Not Yet Fulfilled (Issued) - If the decal is lost, destroyed, or has not yet been issued, the owner/TPWD processor must indicate so by selecting the applicable box on the form PWD 143M.

Description of Required Documents (Continued):

Release of Lien - To remove a recorded lien, a release of lien must be provided. One of the following formats is acceptable to meet the release of lien requirement:

- (1) Form PWD 403 (release of lien section completed), or
- (2) Form PWD 231, or
- (3) The recorded lien holder signs and dates the release of lien on the actual Certificate of Title, or
- (4) Release of Lien on recorded lien holder's letterhead or prescribed form that includes: Description of the vessel and/or outboard motor (make, TX or serial number and year built); title number if available; owner(s) name; statements that the debt has been paid in full and/or the financial institution no longer has an interest in the vessel and/or outboard motor; signed by a representative authorized to release the lien; and the firm's name. The lien holder's signature must be notarized.

Legal Documents - includes, but is not limited to, the following support documents:

- (1) divorce decree,
- (2) for a legal name change - a copy of the court order,
- (3) for a name change due to marriage - a copy of the marriage certificate.

Verification of Vessel or Outboard Motor Serial Number (PWD 504) - is required when verification of hull identification (HIN) and/or outboard motor identification (MIN) number is necessary. You must attempt to trace these number(s) by placing the form PWD 504 on top of the serial number(s) and rubbing a pencil across the paper so that an impression appears on the form. If the number(s) are not clearly legible after tracing, please write the number(s) in the area provided. In lieu of the pencil tracing, you may attach a photograph of the serial number(s) to the form PWD 504. If a photograph is supplied, the number(s) must be legible in the photo. The form PWD 504 must be signed by the applicant/purchaser or the seller/donor.

*** By law, the identifying serial number must be attached to the vessel or outboard motor.** If the vessel or outboard motor does not have a serial number, inspection by a Game Warden is required. After the inspection, the Game Warden will either assign and attach a new serial number or will verify and attach the original serial number. Contact your local TPWD Law Enforcement Office for a review of documentation that will initiate the inspection process. An Affidavit for Proof of Ownership of Vessel or Outboard Motor (Form PWD 736 - available only at TPWD offices) must be completed by the applicant and then signed by the Game Warden at the time of the inspection.
