**LEGAL GAME • 2023-2024**  
**OSR Required Each Day**  
**Waterfowl: FLAG POND ONLY.** Shooting hours end at noon. Hunting is allowed each day of the **Early Teal, North Zone Duck, and Extended Falconry seasons.**  
**SPECIAL REGULATIONS:** Hunting is restricted to Flag Pond only. Access to and from the hunt area is by boat only. Airboats are prohibited. No hunting allowed from shoreline. For more information, call Nails Creek State Park at (979) 289-2392.

**OSR Required Each Day**  
**Archery Only White-tailed Deer Season:** Sept. 30-Nov. 3 and Nov. 23-26 (either sex) and Nov. 4-Jan. 7 (buck only). Bag limit - 2 deer (1 buck and 1 antlerless). **LEGAL BUCK** must have at least one unbranched antler or have an inside main beam spread 13 inches or greater  
**Archery Only Feral Hog:** No Closed season (no bag limit). Baiting allowed Apr. 1-Aug 15.  
**Squirrel, Rabbits & Hares:** Jan. 8-Mar. 31 (use of dogs allowed). Falconry may be used to hunt these species during these dates.  
**Furbearers:** Nov. 4-Mar. 31, Night only (use of dogs allowed). Shotguns are the only legal means that may be used.  
**Waterfowl:** Hunting is allowed each day of the **Early Teal, North Zone Duck, and Extended Falconry seasons.**  
**Dove:** Every day of Central Zone Dove season. **Fishing:** No APH or LPU permit required.  
**Means Restriction:** Firearms restricted to shotguns with no larger than #2 shot. Non-toxic shot must be used for waterfowl hunting. Air-rifles maybe used for Rabbit, Hares, and Squirrels.  
**SPECIAL REGULATIONS:** Only hunters are required to possess an APH Permit. NO ORVs or ATVs allowed; for information regarding disabled access contact Nails Creek SP. See Prohibited Acts for further restrictions.
