ENTIRE AREA CLOSED FOR NON-COSUMPTIVE USE AND GENERAL VISITATION: Nov. 1-10 and Feb. 1-Mar. 31.

LEGAL GAME • 2024-2025

All public users must perform on-site registration (eOSR) in the Texas Hunt & Fish app. Parking at designated access points or boat ramps only. No Motor Vehicle Access.

- Dove: Special Season:** Each day of Special White-winged Dove days. **Regular Season:** Each day of South Zone Dove. **Falconry:** Nov. 15-Dec. 1.
- Quail:** Oct. 26-27; Nov 18-Dec 1; Dec 13-22; and Jan 11-19.
- Waterfowl:** Each day of the **Early Teal, South Zone Duck Youth, Veteran/Active-Duty Military Season, South Zone General Season, Early Canada Goose and East Zone Dark Goose. Falconry South Zone Duck:** Jan. 27-Feb. 10. (See area closed dates for access information). When the land areas are closed, all waterfowl hunters may access the lake through public boats ramps but must remain within the first 50 feet of the bank from the existing waters edge on both the north and south shores of the lake. North Shore State Park Shoreline is open for waterfowl hunting only
- Sandhill Cranes: Zone C** - May be taken during the dates for waterfowl provided the season is open for Sandhill Cranes.
- Rails, Gallinules, Snipe, Moorhen and Woodcock:** May be taken during the dates for waterfowl provided the season is open for these species.
- Rabbits & Hares:** Concurrent with dove and quail hunts.
- Fishing:** No APH or LPU permit is required to fish or access the lake through public boat ramps. Fishing from the banks by access through the WMA is prohibited.

SPECIAL REGULATIONS: All legal watercraft, including Airboats, are allowed on Choke Canyon Reservoir. Park and walk-in only. **Certain compartments are closed** for research, habitat management, or demonstration purposes. Please call the Area Office at 361/274-3573 ahead of time for further details. See Prohibited Acts for further restrictions.
