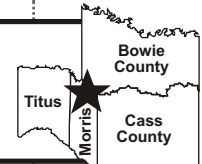


# White Oak Creek WMA Unit #727 25,777 acres

**NOTE:** Please report the harvest of any deer on this WMA during the archery season to 903-884-3800. Please leave your name, county of harvest, and gender of the deer.

**Means Restriction:** Firearms are restricted to shotguns and rimfire rifles or handguns except during Feral Hog General Season and Squirrel Season.

**SPECIAL REGULATIONS:** Entrance at designated entry points is required. **Only hunters are required to possess the APH Permit.** Waterfowl decoys may not be left set out overnight. Equestrian and fishing visitors are required to possess either an LPU or APH. Equestrian trails are open all year except when the entire area is closed. All posted campground rules must be followed.

**DISABLED ACCESS:** Registration at the WMA HQ is required. Trails may be closed to OHV ADA use during inclement weather conditions or periods of flooding. Call the WMA HQ for more information (903-884-3800).

**ENTIRE AREA CLOSED:** Oct. 28 - 29,  
Nov. 4 - 6 & 15 - 17.

**LEGAL GAME • 2023-2024**  
**OSR Required Each Day**

**Archery Only White-tailed Deer Season:** Sept. 30-Jan. 7. Bag limit - 1 deer (either sex). **LEGAL BUCK** must have at least one unbranched antler or an inside spread of at least 13 inches.

**Feral Hog:** (no bag limit).

**Archery Only Season:** Sept. 30-Jan. 7 except dates **ENTIRE AREA CLOSED.**

**General Season:** Jan. 8-Mar. 31. No Firearm restrictions. The use of dogs is only allowed from Feb. 1-29. Dog identification required.

**Dove:** Sept. 1-30.

**Waterfowl:** Shooting hours - one half hour before sunrise to noon. Hunting is allowed each day of the **North Zone Duck** and **Early Teal** seasons, except dates **ENTIRE AREA CLOSED.**

**Woodcock and Snipe:** Dec. 18-Jan. 31.

**Squirrel:** Oct. 1-Feb. 25. (All legal means).

**Coyotes, Furbearers, Rabbits, and Hares:** Sept. 1-Apr. 14. No bag limit.

**Fishing:** Year-round except dates **ENTIRE AREA CLOSED.** Local rivers and creeks are not WMA property.

**YOUTH HUNTS**  
**Youth Only Squirrel:** Sept. 23-24. Coyotes, rabbits, and hares may also be taken.
