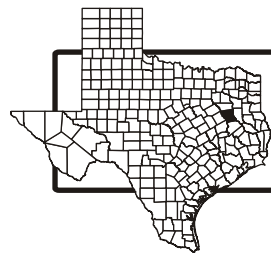

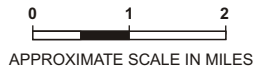

**YOUTH HUNTS**  
**Youth Only Deer:** Oct. 27-28. Bag limit 2 either sex (limit 1 buck). Legal bucks must have one unbranched antler or a main beam spread equal to or greater than the ear tips. Unlimited feral hog.

Freestone County

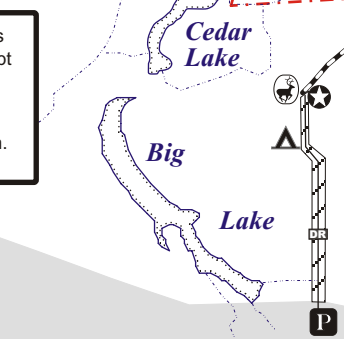
**ENTIRE AREA CLOSED:** Sept. 28-Oct. 22, Nov. 2-Dec. 10, Feb. 8-10 and Feb. 22-24.

**SPECIAL REGULATIONS:** No legal access from the Trinity River or from any location except a Designated Entrance. Camping allowed in Designated Campground Area only. Hunter access begins at 5:00 a.m. each day. Hunters may not leave the parking area before 5:00 a.m. each day.

**LEGAL GAME • 2018-2019**  
**OSR Required Each Day**  
**NO WHITE-TAILED DEER HUNTS** by APH permit on this area except for Youth Only Deer hunts.  
**Feral Hog:** Mar. 1-Apr. 30 (no bag limit). Only legal firearms, archery, and crossbows may be used to take feral hogs. Use of dogs and trapping are prohibited.  
**Waterfowl:** Dec. 11-Jan. 27 provided these dates fall within the North Zone Duck season. Shooting hours are one half hour before sunrise to noon.  
**Woodcock, Gallinules and Snipe:** May be taken during the shooting hours and hunt dates for waterfowl during the open seasons for these species.  
**Squirrel, Rabbits & Hares:** (Rimfire or shotgun) Dec.11-Jan. 27.  
**Fishing:** Except on dates ENTIRE AREA CLOSED.  
**SPECIAL REGULATIONS:** General access to the area is by APH and LPU Permit only during daylight hours at designated entry point. Dogs are prohibited except each permit holder may possess one dog while hunting waterfowl, squirrel, rabbits, or hares. See Prohibited Acts for further restrictions.
