

ON-SITE REGISTRATION FORMS AND **eOSR**

Public Hunting Lands

Some units in this booklet require on-site registration (OSR) for entry or participation in certain activities. OSR forms are generally available at the registration station and here in the back of this booklet to comply with on-site registration requirements. See the On-site Registration of the “Questions and Answers” section for more information.

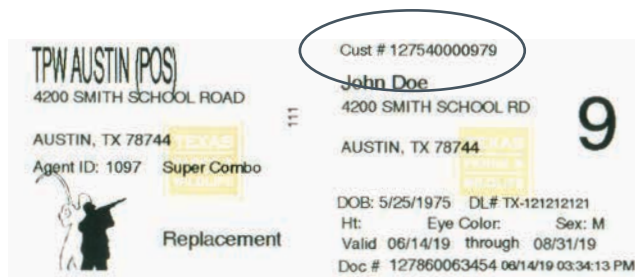
Paper OSR Instructions:

You must fill out the top portion (Part A) of the form and deposit it in the registration box before beginning your activities on the Area. The bottom portion (Part B) must be filled out and placed in the registration box before leaving the Area. Photocopies are acceptable if additional forms are needed.

Electronic On-Site Registration is a new smartphone and web app available through the Texas Hunt & Fish App: tpwd.texas.gov/huntandfish that can be used to perform on-site registration on all dove and small game field and Public Hunting Lands (PHLs). Please note that most WMAs, and State Parks require On-Site Registration to be performed using the area specific paper forms only.

Look for the electronic on-site registration badge **eOSR** on the unit map in this booklet for at the information station to determine if your hunt location is eligible.

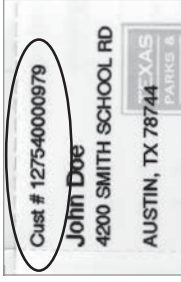

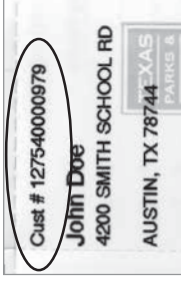
