


## Nannie Stringfellow WMA Archery Deer

## **Background**

The Nannie M. Stringfellow WMA is located 14 miles southwest of Lake Jackson and 7 miles southeast of Sweeny on County Road 316. The hunter check station is 2 miles north of the intersection of FM 2611 and County Road 316 and 3 miles south of the intersection of FM 521 and County Road 316. The WMA is approximately 3,666 acres of primarily bottomland hardwood forest which lies within the San Bernard River floodplain and is subject to frequent flooding. All hunters will be assigned specific areas.



## Special Drawing - Archery Deer Hunt

- 1. The hunt will be conducted from 12:00 pm on Monday through 12:00 pm on Friday for the specified hunt period.
- 2. Hunters may begin check-in at the hunter check station at 10:00 am on the first day of each hunt period. A hunter orientation will follow before hunters will be allowed afield. Standby hunters should report to the hunter check station by 10:30 am on the first day of the hunt period to complete the application process. Standby hunters will be drawn as vacancies permit. All standby hunters will be drawn at 11:00 am.
- 3. Only persons drawn for permits will be allowed in the hunt area. Permitted non-hunting adults may supervise youths during any hunt but must possess a valid hunting license. All hunters will be assigned compartments. Assignments will be made based on accessibility of the area, the type of vehicle the hunter will use and the size of each hunt party.
- 4. All persons involved in the hunt must check-in and checkout with Texas Parks and Wildlife Department personnel when going to and coming from assigned hunting compartments.
- 5. Firearms are prohibited.

- 6. Legal means for this hunt are compound bow, longbow, recurve and crossbow. Archery hunters do not have to wear hunter orange while in the stand. Hunter orange is mandatory when hunters are on the ground trailing a hit animal and when returning to their vehicle. All hunters must visibly wear a minimum of 400 square inches of hunter orange material with 144 inches appearing on both chest and back and orange headwear. A blaze orange vest and cap will meet requirements.
- 7. Hunters will be allowed limited use of their ATV to access the WMA. All vehicle travel will be restricted to designated road right-of-ways.
- 8. Each hunter may bring up to 2 portable blinds/stands which must be removed at the end of the hunt period. Screw-in attachments are prohibited.
- 9. Hunters with mobility disabilities may hunt from a stationary vehicle. Baiting is allowed. Corn must be tested for aflatoxin, safe for wildlife consumption and remain in the original container in which it was purchased.
- 10. Bag limits and antler restrictions will be explained during hunter orientation. Hunters who harvest deer will be issued TPWD Special Drawn Deer tags by TPWD personnel. Hunters will not need to use tags from their hunting license.
- 11. Alcohol is prohibited on the WMA.
- 12. Selected hunters must present the following:
  - 1) Valid Texas hunting license with archery endorsement.
  - 2) Valid identification
  - 3) Hunters education card Required of Texas hunters born on or after September 2, 1971.
- 13. No camping or open fires are allowed on the WMA. Commercial facilities are available in Lake Jackson.
- 14. Do not litter on the WMA. Pick-up all personal and hunting-related litter.
- 15. Hunters in the field and vehicles on the WMA are subject to inspection by WMA personnel and game wardens.
- 16. Accommodations for hunters with disabilities on public hunt sites vary between areas. If you would like to request accommodation, please contact each area directly at least 2 weeks in advance of your hunt to discuss the options that may be available.
