


James E. Daughtrey WMA E-Post Card– Feral Hog/Predator Hunts

The James E. Daughtrey WMA covers over 31,000 acres including Choke Canyon Reservoir between Three Rivers and Tilden in Live Oak and McMullen Counties. The WMA was named in honor of State Game Warden James E. Daughtrey of Tilden who was fatally injured in an automobile collision while pursuing game law violators. Approximately 6,000 acres of uplands are open to public hunting by Annual Public



Hunting Permit at conservation pool. The terrain is generally flat with thorny brush dominated by mesquite, black brush and cacti. E-post card hunts for archery deer, feral hogs and coyotes will be limited to specific compartments on drawn dates as published annually. Only specific areas identified during orientation will be open. Some areas are accessible only by boat or significant hiking by foot. Hunters should take this into consideration before applying for this hunt. Some roads provide access to limited areas.

All hunters must attend a mandatory orientation at 11:00 a.m. on the first day of the hunt period. Hunt ends at dusk or on the last day of the hunt period. A primitive campground is located at the area headquarters and will open the evening before the start of the hunt. Please contact the WMA if you intend to arrive early to use the campground prior to the hunt. Drinking water and electrical hookups are <u>not</u> available. A limited number of fire rings and picnic tables are provided on a first come, first served basis. There are no cold storage facilities available on site. Camping is also available at Choke Canyon State Park—Calliham Unit (361) 786-3538. Other restrictions as follows:

1. All hunters must attend a mandatory orientation at 11:00 a.m. on the first day of the hunt period. Hunt ends at noon on the last day of the hunt period depending on hunt type. Stand-by positions may be available. Prospective stand-by hunters must register by 11:00

- a.m. to participate in the drawing. If you cannot attend orientation the hunt staff may offer makeup dates.
- 2. At all times while on-site hunters must have on their person a valid e-Post Card confirmation, valid state issued driver's license or ID card, Annual Public Hunting Permit, a Texas hunting license and any special stamp as required by statute. Only hunters drawn for the E-post Card hunt will be admitted.
- 3. A permitted supervising adult must accompany hunters under the age of 17. Adults accompanying youth must be 17 years of age or older, possess a valid Texas hunting license, have completed a hunter education course or be exempt and must be within normal voice control.
- 4. **Non-permitted participants will not be allowed to accompany hunters into the field.**Hunter Education is required of all hunters born on or after September 2, 1971 (See Outdoor Annual for more information).
- 5. Hunters must visibly wear a minimum of 400 square inches of daylight fluorescent orange material, with at least 144 square inches appearing on both chest and back; daylight fluorescent orange headwear is also required regardless of hunt method.
- 6. <u>Daily Electronic On-Site Registration (eOSR) is required.</u> Check in, check out, and harvested animals will be recorded through the My Texas Hunt Harvest app. (See staff for more Information).
- 7. Only legal archery equipment, shotguns with slugs or muzzleloaders are allowed. No buckshot allowed.
- 8. **Bag Limit:** Unlimited feral hogs and coyotes. No other animal game or non-game may be taken or possessed.
- 9. **Portable stands are allowed and baiting may be permitted.** All equipment must be removed before the end of the hunt period. **All equipment must be labeled with hunter's name and phone number.** If allowed, corn must be certified less than 20 ppb aflatoxin free.
- 10. All-terrain vehicles (ATVs) and off-road vehicles (ORVs) are not permitted on the WMA, except for use by a hunter with a documented mobility disability. Proof of mobility disability is required.
- 11. Alcoholic beverages may not be publicly displayed or consumed on the WMA and persons under the influence of alcohol/drugs will not be permitted to enter the hunt area. All open container, DUI and DWI regulations will be enforced.
- 12. Transporting youth (under 18 years of age) in an "open bed" of a pickup truck or trailer is prohibited on roads within the boundaries of the Wildlife Management Area.

- 13. Hunters in the field and vehicles, including boats, within the WMA are subject to inspection by WMA Personnel and/or Game Wardens. Do not take any plants, animals (other than legally taken game) or artifacts from the WMA, including shed deer antiers or skulls. Any artifact found must be left as they are.
- 14. Accommodations for hunters with disabilities on public hunt sites vary between areas. If you would like to request accommodation, please contact each area directly at least 2 weeks in advance of your hunt to discuss the options that may be available.
