

Carter P. Smith Executive Director Thank you for your participation on the San Marcos River Task Force. To aid in the work of the Task Force, I am hopeful that you can provide to me some items referred to in: the February 2015 "Memorandum of Understanding" between Texas State Tubes (TST) and RKY, Ltd. (the "February 2015 MOU"); and the "Proposed Memorandum of Understanding (MOU) Between Texas State Tubes LLC and RKY Ltd. and the Counties of Caldwell and Guadalupe" (the Proposed MOU) that was submitted to the House Committee on Special Purpose Districts in its hearing on Senate Bill 234 on May 20, 2015.

Specifically, it would be helpful for me to receive:

- The September 2015 yearly report to the Guadalupe and Caldwell county commissioners regarding "the results of our river cleanup, security and communication/awareness activities" referred to in the February 2015 MOU:
- The third-party audit of all funds expended referred to in the February 2015 MOU;
- The monthly or quarterly reports referred to in the Proposed MOU;
- Any records of financial assistance provided by TST to Guadalupe or Caldwell county;
- The "property owners' hotline" number and any information regarding calls to the hotline;
- A signed copy of the Proposed MOU;
- Information about law enforcement staffing and expenditures and river cleanup expenditures; and
- Any other information about the February 2015 MOU or the Proposed MOU you would like the Task Force to know.

So that this information can be considered at the scheduled August 1, 2016 Task Force meeting, I am hopeful of receiving this information by July 15, 2016.

In addition, the agenda for the August 1, 2016 Task Force meeting will include an opportunity for TST to make a presentation and answer questions regarding its experience with the February 2015 MOU and the Proposed MOU.
