Thank you for agreeing to participate in the San Marcos River Task Force. By this letter, I am inviting you to the first meeting of the Task Force, to be held on March 7th, 2016 from 2:00 p.m. to 4:00 p.m. in the Commission Hearing Room at Texas Parks and Wildlife Headquarters in Austin, Texas (4200 Smith School Road). I am looking forward to meeting you and beginning to work on our Task Force Charge:

To bring together a broad spectrum of stakeholders to provide perspective to the Texas Parks and Wildlife Department and Commission regarding the issues associated with recreational river use on the San Marcos River from the bridge at County Road 101 to Scull Crossing. This 3.6 mile river segment flows through Hays, Caldwell, and Guadalupe Counties. Specifically, the task force is charged with studying and making recommendations concerning how to control illegal behavior, improve public safety, safeguard private property rights, and conserve environmental quality and the natural state in this segment of the San Marcos River.

It is my expectation that we meet every two months over the next seven months, and will have our final report to the TPW Commission no later than October 1, 2016. For your planning purposes, we will attempt to meet at some point during the first or second week every other month starting in March 2016.

I very much appreciate your commitment and interest in this issue, and am looking forward to working with you.
