Important: (1) Applicants 17 years of age or older are required to attach a copy of their valid Texas driver's license issued at least six months prior to application by the Texas Department of Public Safety; (2) If applicant holds a current year license including the same privileges (hunting, fishing or combination) as being applied for, then the original current year license must be surrendered to TPWD along with this application; (3) The applicant must have been a resident of Texas more than six months immediately before applying for this lifetime license; (4) Applicant understands that lifetime licenses may be suspended or revoked in accordance with Parks and Wildlife Code 12.501; and (5) Additional fees for hunting and/or fishing privileges may be required in the future.

ADDITIONAL GIFT INFORMATION

If you are trying to surprise someone with a lifetime license and do not have the required documentation to submit, TPWD can issue a gift certificate. If Section 7 is not complete, TPWD will contact the applicant listed in Section 4 directly for any information needed.

The gift certificate and notification of required documentation needed to process the application will be mailed to the individual listed in Section 7. If required documentation is not received before the expiration date of the gift certificate, the lifetime application will be withdrawn.
