Copies of the invoice must be retained by the seller and receiver for one year or, for the receiver, as long as the fish are in			
possession; whichever is longer. Receivers of triploid Grass Carp must also keep certification documentation for one year or as long as the fish are in the water, whichever is longer. The seller shall provide the invoice (this applies to shipments from out-of-state dealers as well). Sellers or their employees transporting controlled exotic species must also be in possession of a copy of their exotic species permit. Shipments of triploid Grass Carp must also be accompanied by documentation of triploid status certification. Private pond owners transporting triploid Grass Carp must be in possession of a copy of their permit for the fish. Mozambique tilapia and triploid Grass Carp possessed in a private pond or facility may not be sold or transferred live and may only be removed from those premises if killed.
