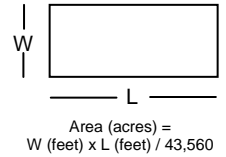

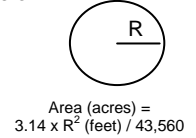

**Area Calculations**

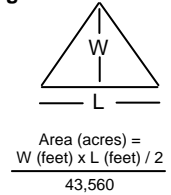
