

TEXAS PARKS AND WILDLIFE DEPARTMENT

EXECUTIVE DIRECTOR ORDER NO. 07-008

The Executive Director of the Texas Parks and Wildlife Department ORDERS the following additions to the information contained in the department publications entitled "2007-2008 Public Hunting Lands Map Booklet":

1. Nannie M. Stringfellow Wildlife Management Area (Unit 716): Additional postcard selection feral hog hunting: March 3-7, 2008 (20 positions).
2. Guadalupe Delta Wildlife Management Area - San Antonio River Unit (Unit 760): Additional postcard selection general hunts: January 18-20 and Jan. 25-27, 2008 (One group per hunt period). Waterfowl, feral hogs, squirrel, rabbit, and hares may be taken. Fishing is allowed.
3. Guadalupe Delta Wildlife Management Area - Hynes Bay Unit (Unit 724): Additional feral hog hunting by Annual Public Hunting Permit: January 28 – March 31, 2008. Archery and shotgun with buckshot only. No baiting. No blinds. Hunter-orange regulations apply. Shooting hours are one half-hour before sunrise to one half-hour after sunset. Access begins at 4:00 a.m. and all hunters must exit the area by one half-hour after sunset. All persons using the unit must obey all regulations posted at the information station.
4. Justin Hurst Wildlife Management Area (formerly Peach Point WMA; Unit 721): Additional waterfowl hunts by Annual Public Hunting Permit or Regular Permit: Youth/adult waterfowl hunting: January 6 and January 20, 2008. Goose: February 2, 2008. Hunters are required to check in and check out at the designated check station by noon. Shooting hours are one half-hour before official sunrise until noon.
5. Caddo Lake Wildlife Management Area (Unit 730): Additional feral hog hunting by Annual Public Hunting Permit: March 10-16, 2008. Additional hunting for furbearers and predators: March 10-16, 2008. Trapping is allowed.
6. Gus Engeling Wildlife Management Area (Unit 754): Additional feral hog hunting: April 1-30, 2008 (All legal means may be used). No trapping or use of dogs.
7. Richland Creek Wildlife Management Area (Unit 703): Additional feral hog hunting: May 1 – 31, 2008 (All legal means may be used). No trapping or use of dogs.
8. Big Lake Bottom Wildlife Management Area (Unit 733): Additional feral hog hunting: May 1 – 31, 2008 (All legal means may be used). No trapping or use of dogs.
9. Tony Houseman Wildlife Management Area (Unit 712): Additional feral hog hunting (no bag limit): Apr. 1-30, 2008. (All legal means may be used except shotguns with buckshot).

This order is issued pursuant to §81.402 of the Texas Parks and Wildlife code and is effective immediately.
