### Search the Electronic State Business Daily (ESBD)

When state entities have contract opportunities over \$25,000, they must advertise them on the Electronic State Business Daily. This online search engine is available to anyone and allows you to find bid opportunities by type, entity, vendor award or National Institute of Governmental Purchasing Codes.

### Explore HUB Subcontracting Plan Opportunities

Subcontracting is another excellent opportunity for your business. When a state contract's expected value is \$100,000 or more, state entities carefully examine it for subcontracting opportunities. If opportunities are found, bidding vendors must submit a subcontracting plan showing potential use of certified HUBs. Become familiar with the subcontracting process. Once certified, your listing in the online Texas HUB Directory will make your business known as a potential subcontracting partner.

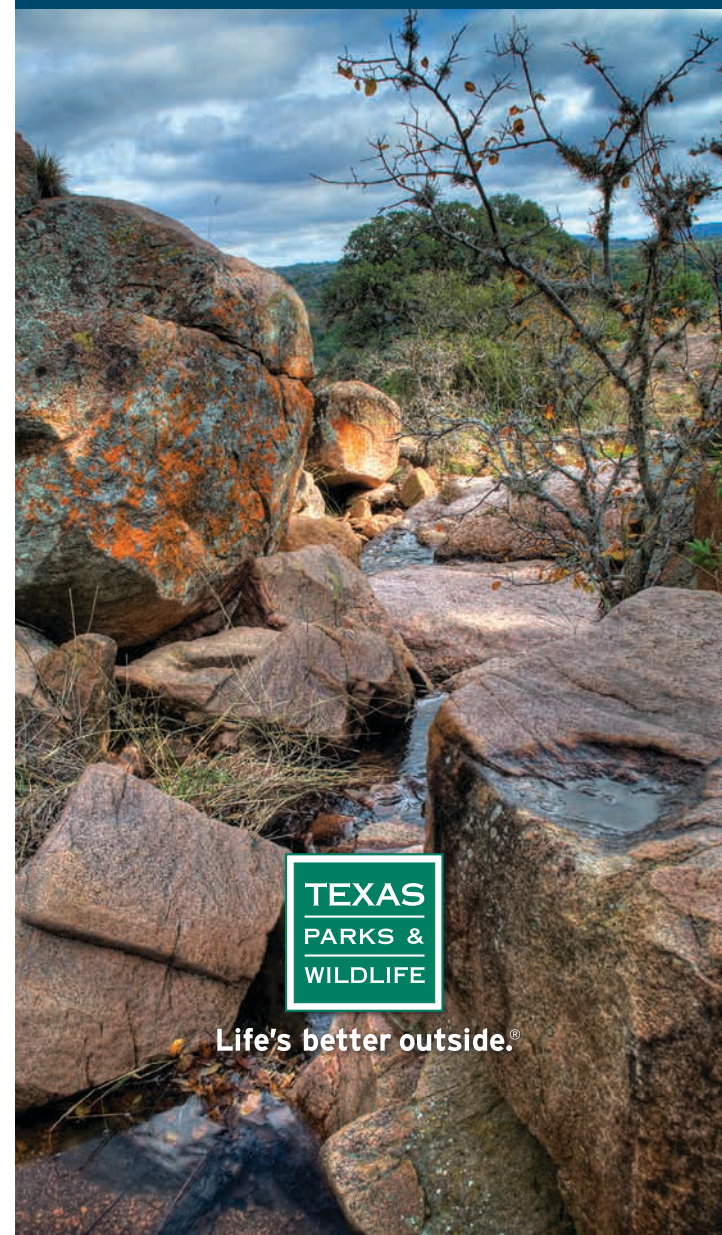

## NOT ON THE CMBL OR HUB CERTIFIED?

State agencies are unable to locate your business — increase visibility by registering for the CMBL or becoming HUB certified.

*State agencies and other purchasing entities have two ways of locating vendors to participate in solicitation opportunities.*

**1 Centralized Master Bidders List (CMBL) –**  
The CMBL is a database maintained by the Comptroller containing the names and addresses of registered vendors used by State of Texas purchasing entities seeking vendors for the agency's solicitations.

**2 Historically Underutilized Business (HUB) Directory –** A search engine used to find non-CMBL Texas-Certified HUB vendors that are able to provide requested goods or services.

State agencies utilize the CMBL, in conjunction with the HUB Directory, to obtain a vendor list to send the solicitation documents. Below are the minimum requirements for each type of solicitation.

### Purchases up to \$5,000

Considered spot purchases by agencies, competitive bidding is not required although purchasers may utilize the CMBL and HUB Directory to find vendors that are able to provide the needed goods or services.

### Purchases of \$5,000.01 to \$25,000

Agencies must obtain bids from at least three CMBL vendors, two of which must be Texas certified HUBs.

### Purchases over \$25,000

Agencies must solicit bids from all vendors on the CMBL registered under the appropriate class and item code for the requested goods or services in the appropriate geographic region.

### Purchases over \$100,000

Agencies must solicit bids from all vendors on the CMBL registered under the appropriate class and item code for the requested goods or services in the appropriate geographic region. In addition, vendors are required to complete a HUB Subcontracting Plan meeting good faith effort requirements.\*

## REGISTER FOR THE CMBL AND BECOME A TEXAS-CERTIFIED HUB

Be ready for greater business opportunities!

### Benefits of CMBL

- State agencies, colleges, universities and local governments use the CMBL online directory to find vendors.
- Bid notifications are sent directly to YOU.
- Registration is easy with an annual fee of \$70 to help increase your business opportunities.

### Benefits of HUB Certification

- HUB certification is free of charge.
- Certification is valid for four (4) years, provided that business continues to meet the eligibility requirements.
- Business is registered on the Comptroller's web-based HUB Directory. State agencies use the HUB Directory in conjunction with the Comptroller's Centralized Master Bidders List (CMBL) to solicit bids from certified HUBs for state purchasing and public works contracts. Prime contractors also use the HUB Directory to identify HUBs to whom they will send notification of their subcontracting opportunities.
- Increased exposure to the general public, as well as other entities that have a supplier diversity program and are searching for minority-owned, woman-owned, and/or service disabled veteran-owned businesses.

### A "Historically Underutilized Business"...

- is at least 51% owned by a minority, woman and/or service disabled veteran;
- is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23;
- has its principal place of business in Texas; and
- has an owner residing in Texas with a proportionate interest that actively participates in the control, operations and management of the entity's affairs.

In accordance with 34 TAC §20.13, each state agency shall make a good faith effort to utilize HUBs in contracts for construction, services (including professional and consulting services) and commodities purchases.

### CMBL Program

### HUB Mentor Protégé Program

The State of Texas Mentor Protégé Program is designed to foster relationships between prime contractors and Historically Underutilized Businesses (HUBs). The objective of the Mentor Protégé Program is to provide professional guidance and support to the protégé (HUB) in order to facilitate their growth and development and increase HUB contracts and subcontracts with the State of Texas.

State agencies serve as sponsors for the Mentor Protégé agreements. Companies interested in establishing a state Mentor Protégé agreement should:

- Contact a state agency you have already done business with or search the HUB Report for agencies that purchase the goods and services your company provides.
- Ask how they match prospective mentors and protégés
