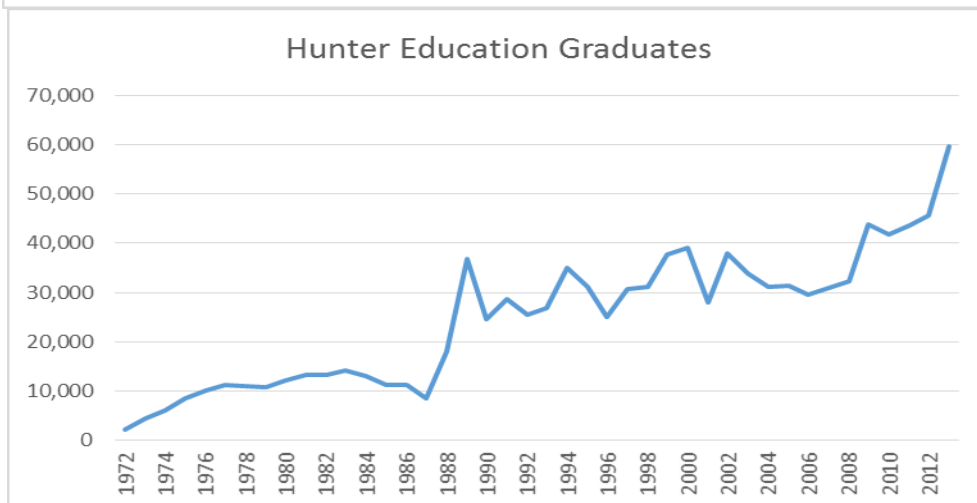
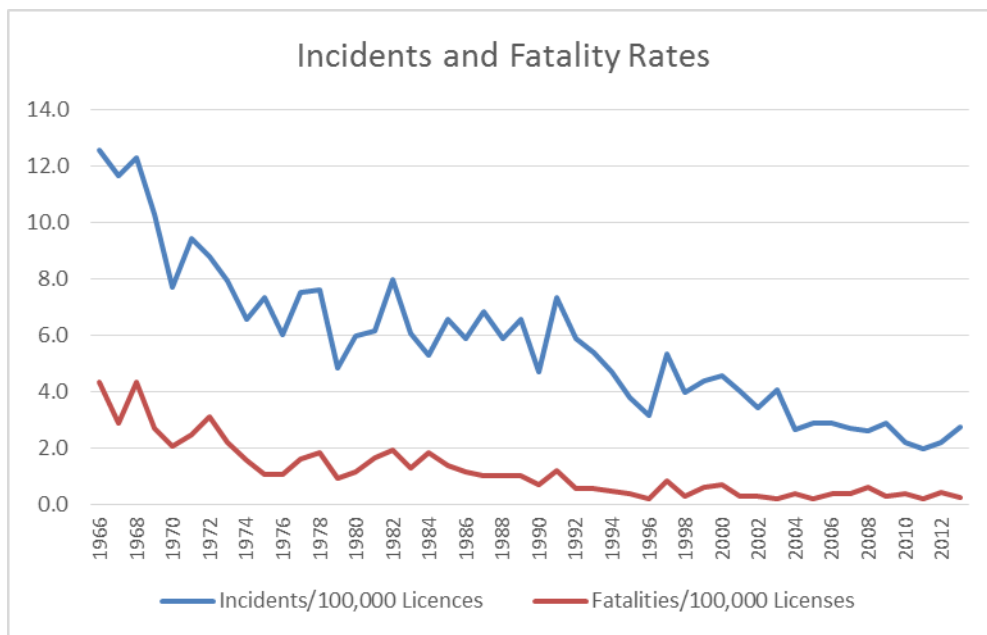

Incident profile over time:

- Almost all were preventable
- Most had no hunter education (safety) course or program
- Not wearing any type of hunter orange clothing
- Lack of judgment or skill
- Over 10 years of hunting experience
- Not under the influence of alcohol
- If self-inflicted, handled firearm carelessly; grabbed trigger; firearm fell
- Distance of muzzle to wound mostly within 10 yards
- Incident occurred towards dusk; fatigue a factor

Significant for 2013

- Over 50% were self-inflicted, caused by careless handling
- Median age of shooters was 34, ranging in age from 9 to 44 years old.
- Median age of victims was 40, ranging in age from 13 to 56 years old
- None of the hunter education graduates in the 2013 incident data took the all-online course
- Number of alcohol or drug incidents up; median age 43, ranging in age from 29 to 48 years old

<i>Prevention</i>	Always point muzzle in a safe direction; treat every firearm as if it is loaded; handle firearms carefully; unload firearms when not hunting; complete hunter education.

<i>Comments:</i>	Shooter was sitting in an elevated stand. Victim was handing a rifle up to the shooter. Shooter reached down to grasp the rifle, accidentally grabbing the trigger. Firearm discharged, fatally shooting victim in the chest.					
<i>Prevention:</i>	Use a haul line to raise and lower the unloaded firearm to an elevated blind; always point muzzle in a safe direction; treat every firearm as if it is loaded; handle firearms carefully; complete hunter education.

<i>Comments:</i>	Shooter and victim were hog hunting on four wheelers. Shooter fired into herd of hogs, striking victim in upper thighs. Victim's four wheeler had no lights.					
<i>Prevention:</i>	Never hunt from a moving vehicle; always identify the target clearly and what is in front of and behind the target; know where others are positioned at all times; complete hunter education.

<i>Prevention:</i>	Always identify the target clearly and what is in front of and behind the target; know where others are positioned at all times; wear hunter orange; complete hunter education.

<i>Comments:</i>	Shooter and victim were kneeling in a blind. Shooter swung loaded firearm to aim at deer. Gun safety was not on and shooter had finger on the trigger. Gun discharged, striking the victim.					
<i>Prevention:</i>	Always point muzzle in a safe direction; finger off the trigger until ready to fire; handle firearms carefully; use the safety; know where others are positioned at all times; complete hunter education.

<i>Comments:</i>	While in the cab of a pickup truck, driver spotted a bobcat to the right of the truck and shot across the cab of the truck. Bullet fragmented, hitting passenger in the back of the head. Apparent use of drugs or alcohol.					
<i>Prevention:</i>	Never discharge firearms while under the influence of alcohol or drugs; know where others are positioned at all times; handle firearms carefully; control the muzzle at all times; never shoot across a vehicle hood, top, trunk or pickup bed; complete hunter education.

<i>Comments:</i>	Shooter shot at hogs from inside a vehicle while it was moving, accidentally firing one round into the roof of the cab of the truck. Part of the bullet struck victim in the head. Apparent use of drugs or alcohol.					
<i>Prevention:</i>	Never hunt from a moving vehicle; know where others are positioned at all times; make sure to identify the target clearly and what is in front of and behind the target; control the muzzle at all times; never shoot across a vehicle hood, top, trunk or pickup bed; complete hunter education.

<i>Comments:</i>	Shooter was handed another's gun, not knowing it was loaded and cocked. While holding the rifle, rifle discharged, hitting him in the leg. Shooter didn't recall touching the trigger.					
<i>Prevention:</i>	Treat every firearm as if it is loaded; handle firearms carefully; control the muzzle at all times; ; unload firearms when no longer expecting to take a shot; use the safety; complete hunter education.

<i>Comments:</i>	Victim was in the top of the tree when he fired at something, then fell 15 feet to the ground, impaling himself with the barrel of the rifle.

<i>Comments:</i>	Shooter ran after the snake and handgun discharged as he ran, striking himself in the hip.					
<i>Prevention:</i>	Never run with loaded firearms; use proper field carry at all times; handle firearms carefully; apply what was learned in hunter education.

<i>Comments:</i>	Shooter aimed through scope from elevated third row of ATV, across the top. Bullet struck the soft top's support pole, fragmented and hit two passengers in the vehicle. Although the view from the scope showed an unobstructed shot, shooter didn't account for the offset between the scope and the barrel.					
<i>Prevention:</i>	Handle firearms carefully; know where others are positioned at all times; muzzle in a safe direction at all times; recognize that muzzle is lower than scope and cannot be placed behind an object or on the ground; apply what was learned in hunter education.

<i>Prevention:</i>	Always maintain a safe zone of fire; communicate with hunting companions; know where others are positioned at all times; identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; apply what was learned in hunter education.

<i>Prevention:</i>	Always maintain a safe zone of fire; communicate with other hunters; know where others are positioned at all times; complete hunter education.

<i>Comments:</i>	Shooter and 13 year old victim were hunting from the rear of the vehicle. Shooter laid rifle down to get out of the vehicle. Rifle discharged, striking victim.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; unload firearm when not hunting; use the safety; know where others are positioned at all times; complete hunter education.

<i>Comments:</i>	Shooter pulled firearm out of its case, touched the trigger and it discharged, hitting another hunter. The stored firearm was put away loaded and safety was not on.					
<i>Prevention:</i>	Always unload firearms when not hunting; store ammunition separately from firearms; always point the muzzle in a safe direction; use the safety; apply what was learned in hunter education.

<i>Comments:</i>	Shooter/Victim saw a rabbit running, cocked the firearm and ran after it. He tripped over a rock, fell and the gun fired.					
<i>Prevention:</i>	Never run with a loaded firearm; use a proper field carry to control the muzzle; handle firearms carefully; use the safety; complete hunter education.

<i>Comments:</i>	Shooter/Victim was carrying a loaded rifle while pursuing a squirrel. Shooter accidentally hit the trigger, shooting himself in the leg.					
<i>Prevention:</i>	Never run with a loaded firearm; use a proper field carry to control the muzzle; handle firearms carefully; use the safety; complete hunter education.

<i>Prevention:</i>	Never run with loaded firearms; always point the muzzle in a safe direction; always practice safe field carries; unload before crossing obstacles; apply what was learned in hunter education.

<i>Comments:</i>	Shooter/Victim was loading the rifle when the gun discharged, shooting him in the hand.					
<i>Prevention:</i>	Always control the muzzle and keep it pointed in a safe direction; handle firearms carefully.
